MINUTES OF A SPECIAL MEETING OF THE BOARD OF DIRECTORS OF THE ORCHARD FARMS METROPOLITAN DISTRICT (THE "DISTRICT") HELD SEPTEMBER 12, 2024

ADMINISTRATIVE MATTERS

Call to Order:

The meeting was called to order at 1:01 p.m.

Quorum and Reaffirmation of Disclosures:

A quorum of the Board was confirmed. It was inquired into whether members of the Board had any additional disclosures of potential or existing conflicts of interest with regard to any matters scheduled for discussion at the meeting. No additional disclosures were noted. The participation of the members present was necessary to obtain a quorum or to otherwise enable the Board to act.

Agenda:

The Board requested amending the agenda to a 15-minute time limit per homeowner for public hearings, to add the decision regarding a fence violation on Elizabeth Street, and to add the discussion of fines for a violation on Columbine Place. Following discussion, upon a motion duly made by Director Stutz, seconded by Director McNelly and, upon vote, unanimously carried, the Board approved the agenda, as amended.

PUBLIC HEARINGS FOR FENCE VIOLATIONS

A public hearing was held regarding a fence violation E. 162^{nd} Court. Ms. Ellis provided background regarding the situation. The homeowner provided additional information on the violations. The Board requested Ms. Ellis use District designated envelopes for violations moving forward.

OTHER BUSINESS

Decision for Fence Violations on Elizabeth Street and E. 162nd Drive:

Following discussion, the Board determined to suspend and remove the \$100 fine if the fence is stained by the end of the month for Elizabeth Street and E. 162nd Drive.

Columbine Place Fines:

The Board and Ms. Ellis reviewed the violation history for an owner on Columbine Place. The Board determined to keep all fines in place and offer the homeowner a payment plan, not to exceed 12 months.
